Applicant Instructions for Doctoral Program 2023 (for international students)
Graduate School of Medicine,
University of Occupational and Environmental Health, Japan

Please read this “Applicant Instructions for Doctoral Program” carefully. Recruiting process will be conducted on the basis of ‘Applicant Guidelines for Doctoral Program, Graduate School of Medicine (in Japanese)’. However, there are some parts that differ for international students.

1. Enrollment Limit

The enrollment limit is 40 including both Japanese and international students. There is no special admission quota for international students.

2. Application Requirements

Those who completed or are to complete 18 years of education outside of Japan by March 2023. (Before applying, submit a list of your education history (starting with primary school) to the Educational Affairs Section to confirm if you are eligible or not. Entrance examination fee is non-refundable under any circumstances.)

3. Application Documents

Submit all application documents which are indicated in ‘Applicant Guidelines for Doctoral Program, Graduate School of Medicine (in Japanese)’.

※ All documents must be completed in Japanese.

【Additional documents for international students】

- ① Certificate of Graduation or Certificate of Expected Graduation (University and Graduate School)
- ② Grade transcripts (University and Graduate School): The certificate should be submitted in a sealed envelope.
- ③ Certificate of Degree
- ④ Certificate of Current Employment or Research History
- ⑤ Photocopy of passport
- ⑥ Photocopy of Residence Card
- ⑦ Recommendation letter from the school or institute applicant belongs to (By president, principal, supervisor)
- ⑧ Document from guarantor (specified form)
- ⑨ Medical examination report

4. Screening Procedures

The screening of international students will be done on the basis of the result of the entrance examination, interview, and medical check-up.

Examination Date	Hours	Subject
First Application (Tue) October 4, 2022	10:00 ~ 11:30	Written Test • Foreign Language: English - Use of a dictionary is permitted. - Use of an electric dictionary is NOT permitted.
Second Application (Thu) January 26, 2023	13:00 ~	Oral Test • Fields which applicants apply for Interview • Knowledge of basic Japanese will be tested during the interview.

5. Immigration and Visa Procedures

International students need to obtain a visa to enter Japan. Without the necessary visa upon arrival, you will not be granted permission to enter Japan.

You will need to take care of your own visa application processes when

- Entering Japan for the entrance examination
- Entering Japan as a student (College Student Visa)

Please start the procedure well in advance as it may require substantial time.

6. Exemption of Tuition Fee

There is a tuition fee exemption system for privately funded international students. Those who apply for it and are approved of having outstanding academic record and having serious difficulties in payment of the tuition fee may receive a full or half exemption of the tuition fee.

7. Scholarship

There is no UOEH scholarship system for international students. Privately funded international students can apply for scholarships elsewhere. (International students cannot apply for scholarship of Japan Student Services Organization.)
